

SOUTH CAROLINA LAW ENFORCEMENT TRAINING COUNCIL MEETING MINUTES Monday, March 18, 2024 10:00 a.m.

A meeting of the South Carolina Law Enforcement Training Council (LETC) was held at the South Carolina Criminal Justice Academy on Monday, March 18, 2024. This meeting was advertised in accordance with the South Carolina Freedom of Information Act.

<u>CALL TO ORDER</u> Agenda Item 1

Chief Mark Keel, Chair of the Law Enforcement Training Council, called the meeting to order at 10:01 a.m. Chief Keel called for a roll call of the Council members. The roll was called by Opel Bunn.

Anthony Crosby (2023-CJA-07-03) (South Carolina Department of Public Safety)

Summary: Allegation(s) of willfully making false, misleading, incomplete, deceitful, or incorrect statements to a law enforcement officer, a law enforcement agency, or a representative of the agency, except when required by departmental policy or by the laws of this State. **Request for Final Agency Decision.**

The Hearing Officer Recommended that Council:

- A. Issue its final agency decision, pursuant to S.C. Code Ann. Regs. 37-107 D. finding that the allegation of misconduct filed against Anthony Crosby by the South Carolina Department of Public Safety has been proven by a preponderance of evidence; and
- B. Impose such sanction as the Council in its discretion deems appropriate pursuant to its authority set forth at S.C. Code Ann. Regs. 37-108 A.

Nicholas McManus was present and spoke on his behalf and to answer questions from Council if applicable.

Douglas Barfield, Esquire, was present and spoke on behalf of the Lancaster County Sheriff's Office and to answer questions from Council if applicable.

After hearing statements from all parties, Chief Cornett made a motion to adopt the recommendation of the Hearing Officer and to permanently deny Nicholas McManus's eligibility for law enforcement certification. Director Woods seconded the motion.

Kwa'nas Kiawoh (2022-CJA-06-07) (South Carolina Department of Corrections)

Summary: Allegation(s) of willfully making false, misleading, incomplete, deceitful, or incorrect statements to a law enforcement officer, a law enforcement agency, or a representative of the agency, except when required by departmental policy or by the laws of this State. **Request for Final Agency Decision.**

The Hearing Officer Recommended that the Council:

- A. Issue its final agency decision, pursuant to S.C. Code Ann. Regs. 37-107 D. finding that the allegation of misconduct filed against Kwa'nas Kiawoh by the South Carolina Department of Corrections has been proven by the preponderance of evidence; and
- B. Impose such sanction as the Council in its discretion deems appropriate pursuant to its authority set forth at S.C. Code Ann. Regs. 37-108 A.

Kwa'nas Kiawoh was present to speak on his behalf and to answer questions from the Council if applicable.

John O'Leary, Esquire, was present and spoke on behalf of Mr. Kiawoh and to answer questions from Council if applicable.

John Steadman, Esquire, was present and spoke on behalf of the S.C. Department of Corrections and to answer questions from Council if applicable.

Matt Wentzel, Investigator, was present and spoke on behalf of the S.C. Department of Corrections and to answer questions from Council if applicable.

After hearing statements from all parties, Acting Director Gallman made a motion to adopt the recommendation of the Hearing Officer and to permanently deny Kwa'nas Kiawoh's eligibility for law enforcement certification. Chief Cornett seconded the motion.

Council voted unanimously to adopt the recommendation of the Hearing Officer and to permanently denied Kwa'nas Kiawoh's eligibility for law enforcement certification. *Please note that Director Stirling recused himself from the voting process in this case.*

Saveion Adams (2023-CJA-07-10) (Greenwood City Police Department)

Summary: Allegation(s) of willfully making false, misleading, incomplete, deceitful, or incorrect statements to a law enforcement officer, a law enforcement agency, or a representative of the agency, except when required by departmental policy or by the laws of this State. **Request for Final Agency Decision.**

The Hearing Officer Recommended that the Council:

- A. Issue its final agency decision, pursuant to S.C. Code Ann. Regs. 37-107 D. finding that the allegation of misconduct filed against Saveion Adams by the Greenwood City Police Department has been proven by the preponderance of evidence; and
- B. Impose a below sanction as the Council in its discretion deems appropriate pursuant to its authority set forth at S.C. Code Ann. Regs. 37-108 A(1-5)
 - 1. Permanent denial and/or revocation (withdrawal) of certification
 - 2. Denial and/or revocation (withdrawal) of certification for a specified amount of time;
 - 3. Certification granted with probation;
 - 4. Certification granted with any additional requirements deemed just and proper by the Council; and/or
 - 5. Public Reprimand

Saveion Adams was present and spoke on his behalf and to answer questions from Council if applicable.

There was no representation for the Department present at this meeting.

After hearing statements from Mr. Adams, Chief Cornett made a motion to adopt the recommendation of the Hearing Officer and to permanently deny Saveion Adams's eligibility for law enforcement certification. Sheriff Faile seconded the motion.

Council voted unanimously to adopt the recommendation of the Hearing Officer and to permanently deny Saveion Adams's eligibility for law enforcement certification. Captain Gallam left the meeting temporarily and did not vote in this case.

Rayonna Johnson (2021-CJA-08-05) (Alvin S. Glenn Det. Center) (Prosecutorial Discretion)

Summary: The Alvin S. Glenn Detention Center wished to exercise prosecutorial discretion pursuant to S.C. Code Ann. § 23-23-150 (B) (2) and declining to prosecute the misconduct allegation. **Request for Final Agency Decision.**

The Hearing Officer Recommended that Council:

- A. Order that the contested case file in this matter be closed; and
- B. Order, pursuant to the requirements of S.C. Code Ann. § 23-23-150 (M), that the "Personnel Change in Status Report: Notification of Separation Due to Misconduct" filed by the Department in this matter be expunged, and that the certification file of the Officer be updated in the records of the Criminal Justice Academy to reflect no outstanding allegations of misconduct based on the allegations reported by the Department in this matter.

Rayonna Johnson was present and spoke on her behalf and to answer questions from Council if applicable.

Captain Moye was present and spoke on behalf of the Alvin S. Glenn Detention Center and to answer questions from Council if applicable.

After hearing statements from Rayonna Johnson and Captain Moye, Director Boyles made a motion to adopt the recommendation of the Hearing Officer and to expunge records within 30 days due to prosecutorial discretion and lack of evidence by the Alvin S. Glenn Detention Center. Chief Cornett seconded the motion.

Council voted unanimously to adopt the recommendation of the Hearing Officer and to expunge records within 30 days due to prosecutorial discretion and lack of evidence by the Alvin S. Glenn Detention Center. Rayonna Johnson is eligible for recertification of her law enforcement certification. Captain Gallam left the meeting temporarily and did not vote in this case.

John Klein (2023-CJA-01-01) (Beaufort County Sheriff's Office) (Prosecutorial Discretion)

Summary: The Beaufort County Sheriff's Office wished to exercise prosecutorial discretion pursuant to S.C. Code Ann. § 23-23-150 (B) (2) and declining to prosecute the misconduct allegation. **Request for Final Agency Decision.**

The Hearing Officer Recommended that Council

A. Order that the contested case file in this matter be closed; and

B. Order, pursuant to the requirements of S.C. Code Ann. § 23-23-150 (M), that the "Personnel Change in Status Report: Notification of Separation Due to Misconduct" filed by the Department in this matter be expunged, and that the certification file of the Officer be updated in the records of the Criminal Justice Academy to reflect no outstanding allegations of misconduct based on the allegations reported by the Department in this matter.

John Klein was present to speak on his behalf and to answer questions from Council if applicable.

Marybeth Mullaney, Esquire, was present and spoke on behalf of Mr. Klein and to answer questions from Council if applicable.

There was no representation for the Department present at this meeting.

After hearing statements from Marybeth Mullaney, Director Boyles made a motion to adopt the recommendation of the Hearing Officer and to expunge records within 30 days due to prosecutorial discretion and by the Beaufort County Sheriff's Office. John Klein is eligible for law enforcement certification. Chief Cornett seconded the motion.

Council voted unanimously to adopt the recommendation of the Hearing Officer and to expunge records within 30 days due to prosecutorial discretion by the Beaufort County Sheriff's Office. John Klein is eligible for recertification of his law enforcement certification.

Christopher Webb (2021-CJA-09-06) (Charleston City Police Department) (Consent Order)

Summary: Upon approval by Council and in lieu of a contested case hearing, Mr. Webb consents, without agreeing that he committed any alleged misconduct, to permanently and irrevocably surrender and relinquish any and all rights and/or privileges he may have in the future to serve as a law enforcement officer in the State of South Carolina or any other State and/or Commonwealth of the United States of America, due to his permanent medical disability.

Christopher Webb was not present at this meeting.

Caroline Cleveland, Esquire, was present and spoke on behalf of the Charleston City Police Department and to answer questions from Council if applicable.

After hearing statements from Caroline Cleveland, Director Stirling made a motion to approve the Consent Order. Director Woods seconded the motion.

Council voted unanimously to approve the Consent Order.
